REFERENCE REGULATIONS

Following consultation of the www.equatoreaps.com website (hereinafter the "Site"), data relating to identified or identifiable persons may be processed according to Legislative Decree 196/2003 - the so-

called Privacy Code - and the new European Regulation 679/2016, the so-called GDPR.

WHAT PERSONAL DATA DO WE COLLECT, AND WHY DO WE COLLECT THEM

COMMENTS

When visitors leave comments on the site, we collect the data shown in the comment form and the

visitor's IP address and browser user agent string to facilitate spam detection.

An anonymised string created from your email address (otherwise known as a hash) can be provided to the Gravatar service to see if you are using it. The privacy policy of the Gravatar service is available

here: https://automattic.com/privacy/. After approval of your comment, your profile picture is publicly

visible in the context of your comment.

MEDIA

If you upload images to the website, you should avoid using embedded location data (EXIF GPS). This

is because visitors to the website can download and extract any location data from the images.

CONTACT FORM

COOKIE

If you leave a comment on our site, you can choose to save your name, email address and website in

cookies. These are used for your convenience so you do not have to re-enter your details when you

leave another comment. These cookies will last for one year.

If you have an account and access this site, a temporary cookie will be set to determine whether your

browser accepts cookies. This cookie contains no personal data and is deleted when you close your

browser.

When you log in, several cookies will be set to store your login information and screen display options.

Login cookies last two days, while screen options cookies last one year. So, for example, if you select

"Remember me", your login will persist for a fortnight. If you log out of your account, login cookies will

be removed.

Suppose you edit or publish an article. An additional cookie will be saved in your browser. This cookie

does not include personal data but simply indicates the ID of the article you edited. It expires after one

day.

EMBEDDED CONTENT FROM OTHER WEBSITES

Articles on this site may include embedded content (e.g. videos, images, articles, etc.). Embedded

content from other websites behaves precisely as if the visitor had visited the other website.

These websites may collect data about you, use cookies, integrate additional third-party tracking and

monitor your interaction with them, including tracking your interaction with the embedded content if

you have an account and are logged in to those websites.

ANALYTICS

Google Analytics is used on this site. The information generated by the Google Analytics cookie about

your use of the website (including part of your IP address) is transmitted to and stored by Google on servers in the United States. Google will use this information to evaluate your use of the website. It

will provide this information in aggregate form and not linked to your identity through Analytics

reports and other information services (e.g. Google Trends).

Google may transfer this information to third parties where required to do so by law or where they

HOW LONG WE KEEP YOUR DATA
